# 2. Highway Capital Reserve Fund Withdrawal Request - Purchase of a 6-Wheel Dump Truck

The Town Council to consider the approval of the withdrawal request of \$210,945 from the Highway Capital Reserve Fund for the purchase of a replacement 2025 International HV507 SFA with snow plow and controls.

# 3. Communications Capital Reserve Fund Withdrawal Request – Radio System Battery Backups Submitted by Police Chief Brian Levesque

The Town Council to consider the approval of the withdrawal request of \$41,100.84 from the Communications Capital Reserve Fund for the purchase of eight (8) Eaton Uninterruptable Power Supply Systems for the radio communication system for the Town of Merrimack for \$41,100.84. Six (6) units will be used at the Merrimack Police Department and two (2) units will be used at South Fire. Currently we have several units that have failed and are inoperable.

# 4. Solid Waste Disposal Capital Reserve Fund Withdrawal Request – Skid Steer
